




## Grant Focuses on Behavioral Health

The Sisters of Charity Foundation of Canton and the Austin-Bailey Foundation have funded a collaborative grant of \$97,800 to help the Mental Health & Recovery Services Board of Stark County transform behavioral health needs in the community.

These funds will support an assessment of area agencies to ensure resources will be used in a manner that will produce the best possible patient outcomes amid tightening budgets, changing policies, and evolving clinical and business practices. The funds will also be used to support succession planning services to ensure smooth transitions of executive leadership.

Some of the organizations that will benefit from this grant include Community Services of Stark County, Child and Adolescent Behavioral Health, Crisis Intervention and Recovery Center, and Quest Recovery and Prevention Services.



## Fund Raising School Sharpens Skills

For years, the Sisters of Charity Foundation of Canton has been making it possible for area nonprofit development and fundraising professionals to attend the Principles & Techniques of Fundraising course at the Lilly Family School of Philanthropy, The Fund Raising School® at Indiana University. Participants learn methods for helping their nonprofit organization achieve its financial goals. Each participant who completes the training receives a certificate in fundraising management.

The Sisters of Charity Foundation has awarded grants to send several local development officers to this program, including Thomas Turner, president of the Mercy Medical Center Foundation, and Marisa Rohn, vice president of marketing and fund development at Goodwill Industries of Greater Cleveland & East Central Ohio. Both said they were grateful for the opportunity.
