Allendale — Allendale County School District



PROGRAM PARTNER DONATES SERVICES TO HELP CHILDREN SEE A BRIGHTER FUTURE



Optometrist Jennifer Lippens, pictured with two Healthy Learners children, serves dozens of students each year at no cost to Healthy Learners. Jennifer Lippens, OD, hasn't received payment for three years for providing eye exams and glasses to more than 100 children, but she couldn't be happier.

When Dr. Lippens took over the Montague Eye Center practice in Greenwood, South Carolina, in 2008, she decided to offer free eye exams and glasses to all children from Healthy Learners who needed them.

"Healthy Learners was doing a lot of fundraising, which was difficult given the economy. If there was anything we

could do to make the program more successful, we wanted to do it," Lippens said. "It's nothing for us to give a child a pair of glasses for the benefits they receive in the long run."

Paying for medical care and getting children to and from appointments is challenging for parents with limited resources. Healthy Learners takes care of both, which Lippens said sets the organization apart from many other programs and made her want to get involved.

Dr. Lippens has formed a tight friendship with Alice Balentine, a student liaison with Healthy Learners Greenwood, which has helped her understand the organization's specific needs and the importance of its provider partners. Dr. Lippens encourages more providers and donors to get involved with Healthy Learners. "So many of us have been blessed in our lives, so to be a blessing for these children in return is the least we can do," she said. (continued on back page)

PARTICIPANT FEEDBACK

Each school year, Healthy Learners surveys students, parents, teachers and school nurses to gauge their satisfaction with the program and the impact it has. Healthy Learners collected more than 1,200 completed surveys from these four groups. Survey results include:

- 92% of student respondents said they felt motivated to do their best at school after receiving services from Healthy Learners.
- 84% of parents surveyed agreed that Healthy Learners had a direct positive effect on their child's grades.
- 99% of school nurses responding agreed or strongly agreed that many students would not have access to basic health care without Healthy Learners.
- Teachers indicated behavioral or mental health problems (92% of teachers surveyed) and vision problems (61%) as the top two health-related barriers to learning among their students.
- 65% of teachers surveyed observed improvements in classroom engagement with children served by Healthy Learners.

-Rhonda, mom to William (left) and Hunter Rhonda was concerned about her 4-year-old son, William, because he had attention deficit hyperactivity disorder (ADHD) that caused him to have trouble focusing in school (4-year-old kindergarten). He also had multiple learning disabilities. Rhonda didn't know what to do and felt overwhelmed because her family did not have health insurance and did not qualify for Medicaid. She was working 10-hour days making minimum wage and her husband also did not make much money. William's school referred her to Healthy Learners.

The Healthy Learners Dillon office coordinated a doctor's visit, paid for

the visit and paid for ADHD medication. Healthy Learners also covered eye care and glasses, dentist visits and additional doctor visits for William and his older brother Hunter.

Ray Tanner Named Inaugural Champion for Healthy Learners

Ray Tanner, University of South Carolina national champion head baseball coach, was named the first Champion for Healthy Learners. Tanner's award was presented by Matt Shaffer, chair of the Healthy Learners Board of Trustees and senior vice president at BlueCross BlueShield of South Carolina's Major Group Division. Shaffer said that Tanner's life's work is about creating champions and advocating for children who are economically and medically disadvantaged.

"He is a winner, a coach, a father and a champion for all young people on and off the baseball field. His values, determination and commitment to making sure that children in need are helped are in total alignment with the mission, vision and values of Healthy Learners," said Shaffer.

Tanner presented Healthy Learners with a check for \$7,500 from The Ray Tanner Foundation to help support its mission.

Philanthropy Critical to the Mission of Healthy Learners

Christina Walker oversees fundraising for the Sisters of Charity Health System, which is the parent organization for Healthy Learners. As vice president, fund development, she assists Healthy Learners with its fundraising initiatives. Editors of *Healthy Insights from Healthy Learners* discussed with Christina the importance of philanthropy to the mission of meeting the unmet health care needs of children without resources in South Carolina.

WHY IS PHILANTHROPY IMPORTANT TO HEALTHLY LEARNERS?

Healthy Learners cannot exist entirely funded by private foundations. It gets no government money except for a small reimbursement from Medicaid for transportation expenses. Support from individuals and organizations fills the gap between baseline funding from foundations and the cost to provide vital services. How can children learn if they can't see the front of the classroom or concentrate on school work if they have a toothache? Healthy Learners is the only organization of its kind in South Carolina that removes health barriers to learning.

HOW CAN SUPPORTERS PARTNER WITH HEALTHY LEARNERS IN FULFILLING ITS MISSION?

"We would have had to choose whether to buy groceries or pay for the doctor. If I had quit my job to qualify for Medicaid, we would have lost everything because we wouldn't have been able to pay bills."

Today, William is in a first-grade special education class receiving speech therapy and therapy for a comprehension disability. The ADHD medication has helped him focus in school. His grades have improved tremendously. Both William and Hunter now receive Medicaid, but Rhonda is grateful for the help they received.

"It's hard to not get emotional when I talk about Healthy Learners. It's hard to explain just how much they mean to me and our family. They gave me such peace of mind and lifted a tremendous pressure from us," said Rhonda. •

Dr. Lippens has been moved by many of the children she has seen over the years and said she feels blessed to have been a part of their lives, both in the near term and long term.

"By eliminating a learning barrier for a child, we can open up many doors for them. It's bigger than just a pair of glasses. We remove that barrier and let them do what they need to do in the classroom," she added. •
