#### MISSION

Regina Health Center provides compassionate and holistic health care services primarily for members of religious communities, clergy and for other persons needing supportive services or residential nursing care. Regina Health Center is a collaborative ministry sponsored by the Sisters

of Charity Health System.

### 25 Years of Responding to Unmet Needs with the Highest Quality Care

Regina Health Center welcomed its first residents in May 1993, but the seeds of meeting unmet community needs were planted more than 166 years earlier when the Sisters of Charity of St. Augustine (CSA) came to Cleveland from France in 1851 to begin Catholic health care. They served as the city's first public health nurses and opened its first hospital in 1852.

As the CSA Congregation grew, the Sisters continued to respond to unmet needs of the changing times. The Sisters of Charity of St. Augustine established hospitals, schools and dozens of health and social service programs in Ohio and South Carolina.

Mt. Augustine, which now houses Regina Health Center (RHC) and the Sisters of Charity Congregational offices, was built as the motherhouse for the CSA Congregation and opened in 1957. In the 1980s, the need to care for religious being discharged from hospitals was steadily increasing, which was becoming beyond the scope of most congregations to provide appropriate skilled care.

#### **Laying the Foundation**

Sister Rosemarie Robinson, CSA, delegate for religious, and the Conference of Religious Leadership (CORL) began discussing the health care needs of religious communities. CORL includes representatives of the congregations of religious men and women serving in the Diocese of Cleveland. They brought in the Catholic Health Association to study the needs of the

## CREATING A MORE BEAUTIFUL, COMFORTABLE HOME TO CELEBRATE 25 YEARS



How would you feel if one of our esteemed Regina Health Center (RHC) residents told you, "Thank you for caring enough to make my home more beautiful and

comfortable?" If you are like most people, you would probably feel elated that something you did had a deep impact on another in need.

There are many benefits to being charitable, and according to an article in *Psychology*Today, there is a "warm glow" theory that holds that people like making their own decisions to give. In 2018, you will have many opportunities to experience the "warm glow" as RHC continues planning to embark on a much-needed renovation project in conjunction with our 25th anniversary. The original motherhouse, Mt. Augustine, was built and furnished in 1956. While the building is structurally sound, and the expansive grounds remain beautiful, RHC needs a significant investment to modernize the rooms where residents live and rehabilitate, and where care is provided. Some furniture in the nursing care rooms dates to the original motherhouse. In addition, the personal and common living areas are in need of improvement.

Although final costs are not yet in, some of the renovations in the first phase include:

 Update resident rooms with new beds, dressers, window treatments, lighting, flooring and fresh paint

- Renovate the dining and common living areas with new tables, chairs, paint, lighting and flooring
- Remodel the expanded rehabilitation room and add needed equipment

Because this is a large undertaking, we are taking our time to properly plan to ensure the best outcome with the least disruption to residents and staff. Replacing resident furniture in the skilled nursing area will be the first initiative as we continue to plan for the more complex renovations.

While we have been wise stewards of money to have a reserve fund that we can use to begin renovations, your 2018 gift is still important because it will ensure that we can repay our reserve fund and have funds available for the general operations of RHC.

Beyond the "warm glow" you can experience by making a gift in 2018, you can also participate in some of our special 25th anniversary year activities—particularly a gala anniversary event on September 8 (an invitation will go out as the date draws near).

Everyone here at Regina Health Center greatly appreciates you being with us for all or part of our first 25 years and looks forward to your continued loyalty as we celebrate this important milestone. We look to the next 25 years of providing compassionate, exceptional care to those who need it most in a beautiful, comfortable home.

everything she did. Sr. Marie was the kindest sister that anyone could have," explained Dorothy.

When Sr. Elizabeth came to live at Regina Health Center (RHC) in 2012, Dorothy visited often, participating in bible study and Mass with her sister. After a frightening driving experience in 2014, Dorothy decided it was time to move to RHC and be closer to her sister. Reunited, they were paired at the hip, sitting together for meals, attending Mass and bible study, and sharing their love of art with other residents through art classes. Dorothy and her sister spent two wonderful years together until Sr. Elizabeth passed away in 2017.


Although her sister is no longer by her side, Dorothy continues to enjoy her time at RHC. When her family is not visiting, Dorothy can be found just about anywhere but in her room. She enjoys "painting

my face and never having a hair out of place," as she describes her daily routine, before leaving her room to visit with friends throughout the building, walk all three floors daily for exercise, attend Mass daily in the RHC chapel and participate in arts and crafts programs. She also leads an art class, Art with Dorothy, the first Monday of every month and she enjoys resident outings to shop in the community.

Dorothy and her sister grew up in Akron, Ohio. She went on to study art at the Cleveland Institute of Art and then teach art for 25 years at all grade levels within the Akron Public Schools. She married her husband Walter at St. Bernard Catholic Church in Akron. They raised five children, who each attended school at St. Sebastian Parish in Akron, where the family also belonged to the parish.

After retiring, Dorothy joined St. Hilary Parish in Fairlawn, Ohio. She served as the driver for a group of girlfriends, picking them up and going to Mass every morning and sharing an occasional meal out with them. She also enjoyed arts and crafts in her spare time.

Dorothy has been at Regina Health Center for four years and said she values the faith-based atmosphere and dedicated staff. religious in the area. The study concluded that there should be a collaborative effort to provide long-term health care services for the aging religious in Northeast Ohio.

Having hospitals in the area and capacity at Mt. Augustine, the Sisters of Charity of St. Augustine responded by agreeing to convert part of the Motherhouse into a state-of-the-art nursing facility to serve the aging religious.

On behalf of CORL, Sister Mildred Baker, IHM, visited all congregations to speak to sisters about their health care needs. At the same time, the Sisters of Charity of St. Augustine began evaluating the project to determine the feasibility of such a major ministry. With a team focused on fundraising, construction, staffing, clinical care and more, a detailed project plan was developed. The plan was presented to the Sisters of Charity of St. Augustine General Chapter and it was approved.

"The demand was there to develop RHC and there was a desire of religious congregations to participate," said Sister Judith Ann Karam, CSA, congregational leader of the Sisters of Charity of St.

Augustine. "From the beginning, it has been a truly collaborative process. We formed an inter-congregational advisory group, even to the point of asking for input on selecting paint colors. We also looked at what each day would be like at this new facility to respect the needs of each congregation and found ways to incorporate the individual order's community life priorities."


After a previous ministry role was completed, and she took on as CSA Council member, Sr. Judith Ann worked full-time with the team in developing and implementing plans for RHC. Sr. Mildred also came on board as part of the planning team. Sr. Judith Ann and Sr. Mildred returned to the participating congregations to share the vision for RHC, even with Bishop Anthony Pilla joining them on a couple of visits.

Each member of the Inter-congregational group developed plans for their individual congregations around making decisions to participate and preparing for their members' admission. These plans were then shared with the group. A group of physicians from Cleveland, Akron and Canton gave input into the clinical program of RHC and selection of a medical director.

As many as 22 orders within Northeast Ohio collaborated with the Sisters of Charity of St. Augustine to ensure that their aging religious would receive the highest caliber health care services, along with supportive programs that would keep them spiritually, mentally and socially engaged.

#### **Welcoming the First Residents**

After working hard to raise more than \$7.5 million to renovate and convert the facility, including more than \$6 million from the Sisters of Charity Saint Ann Foundation, RHC opened its doors in 1993. The opening and energy of all involved made an impression on Sr. Judith Ann.

"I'll never forget, the Sisters of St. Joseph had 16 sisters come to RHC. They did a marvelous job preparing their sisters to live here, putting quilts from congregational members in each one of their rooms to make them feel at home and connected," she said.

Twenty-five years later and RHC is still thriving. Sr. Judith Ann attributes that to the staff, congregations, families, volunteers and supporters. "The heart and hand of this ministry are the staff and volunteers. We know how our own sisters are cared for, and we know that everyone here is treated with such respect. RHC is a 5-star facility because everybody is a part of this ministry," she added.

In discussing this milestone year and looking ahead to the future, Sr. Judith Ann returned to the collaborative effort that has remained strong for so many years:

"The anniversary is a celebration of all the people who have made RHC work and made it what it is today. RHC will continue to respond to new needs and I know the mission will continue where we can still provide the highest quality, God-centered care and service to residents. We celebrate the past and look forward to the future, and truly thank God for everyone who has been a part of the RHC community." \*

Your rollover will count toward your required minimum distribution and you will avoid income tax on the amount of the gift transfer.

LONG-TERM APPRECIATED SECURITIES — Instead of making a gift with cash, a check or credit card, consider making a gift with long-term appreciated securities (securities you have held for over one year) and avoid the capital gains tax.

**INITIATE A MONTHLY DEDUCTION** from your checking or savings account or from your credit card to spread your annual giving throughout the year.

Because the RHC Board of Directors is placing high importance on the renovation for an improved and safer resident experience, they are prepared to take funds from the coveted reserve fund to begin the project. The reserve fund was established and built to help RHC sustain an overwhelming circumstance such as loss of revenue from a market downturn, growing health care costs, damage to the building or some other unplanned event. The hope is to replace the fund as promptly as possible. Your 2018 gift will not only help support the renovation project, it will ensure that RHC's reserve fund stays intact by replacing the removed funds to begin this costly project.

All donors who make a gift in 2018 will be eligible to designate their gift to support the renovation project or for the general operating fund, which is where most gifts are applied. ### Skilled Therapy Team Promotes Maximum Level of Independence



There are many reasons why someone needs therapy—after surgery, broken bones, a heart attack, stroke, arthritis, respiratory distress and more. Whatever the reason, Regina Health Center has a multi-disciplinary team that includes nursing, social services, therapy and spiritual/social programming to deliver a holistic approach to rehabilitation. The team provides exceptional resident care and clinical excellence in

delivering comprehensive rehabilitation services to enhance daily living skills and restore prior quality of life.

All services and treatments are prescribed by a physician and implemented by trained staff and licensed professionals. Comprehensive rehabilitation services include:

**PHYSICAL THERAPY**—helps increase strength, balance and mobility, and decrease pain and discomfort. The goal is to return to normal activity, and is necessary before the reintroduction of any exercise programs after an injury. The focus is on movement safety to prevent future injuries.

**OCCUPATIONAL THERAPY**—focuses on performing everyday activities, such as feeding and dressing. Transferring and positioning techniques are taught to help participants live more safely and independently. Basic home skills, such as laundry, cooking and microwave use, are also taught. There's even a caregiver education component to help families assist their loved ones safely.

**SPEECH THERAPY**—provided by a licensed, certified speech-language pathologist, these services are designed to help improve communication and clarity of speech. The focus is on identifying strategies to help with memory, as well as breaking down and organizing information to ease the decision-making process. Speech therapy can also help with swallowing disorders, including dietary planning.
