Generous Donors Boost 25th Anniversary Renovation Campaign

Regina Health Center (RHC) celebrated its 25th anniversary on September 8 at Portage Country Club. The highlight of the evening was the announcement of a \$1 Million Matching Gift Initiative for the 25th Anniversary Renovation Campaign to inspire others to join in the efforts to raise a total of \$2.5 million in philanthropic support. The Matching Gift Initiative offers donors a dollar-for-dollar match up to \$1 million for all new gift commitments to the campaign.

Having learned that RHC had started to secure gifts for the Matching Gift Initiative, long-time supporters Katie and Bud Koch decided to make a historic \$500,000 gift commitment, which made them the most generous individual donors in RHC history (as opposed to an estate or organization).

Bud said, “We know how important this renovation is and we wanted to give the renovation a boost to encourage others to make a gift.” Katie added, “We wanted to do more for the mission of caring for these wonderful residents who have spent their lives taking care of others.”

Katie and Bud began supporting RHC 20 years ago when they heard about the Holy-In-One Golf Outing. Bud, an avid golfer, thought the outing was a great opportunity to support a worthy charity and meet others with the same interests. Katie became more involved when RHC started doing home tours in the Glencairn neighborhood in Richfield. Katie and Bud, along with several residents of the area, opened their homes for a special fundraising tour to benefit RHC. Katie participated on the House Tour Committee and later chaired the committee.

The Kochs have been very charitable with annual gifts to RHC, and Katie is on the RHC Board of Directors and has served on several committees, including as the chair of the 25th Anniversary Planning

REJUVENATION IS IN THE AIR



Fall might be in the air, but at Regina Health Center, this is a time of rejuvenation. We're thrilled to announce that the largest facility renovation in our 25-year history will kick off in mid-November. The singular focus of this renovation is to enhance the quality of life for residents, which is why we are focusing solely on resident living and gathering spaces.

We will be updating resident rooms with new beds, dressers, window treatments, LED lighting fixtures, flooring and fresh paint, as well as renovating the dining and common living areas with new tables, chairs, paint, lighting and flooring, and updating and upgrading our rehabilitation unit and nursing stations.

As I've written about previously, these renovations are much needed after 25 years to enhance the experience of our residents and ensure we can continue to provide exceptional care in a warm, welcoming environment. We have undertaken extensive planning for the renovations so that life at RHC is uninterrupted as much as possible. To accomplish that, the project will proceed over the course of approximately 18 months. It will take that amount of time because the contractor will focus on renovating two or three rooms at a time. We'll start with empty rooms and then move to occupied rooms, with residents being temporarily relocated to nearby rooms for no more than two weeks.

Our renovation planning team includes multiple groups with extensive experience in health care facilities, such as Invacare Corp., a manufacturer and distributor of medical equipment; Norman Eckinger, Inc., a project design and general contracting firm with a staff that is certified health care construction trained; and, a committee of staff members, board members and CSA Sisters focused on project financing, functionality and aesthetics (working with a professional interior design firm).

Renovations will begin on the second floor in the B wing, which is our busiest area. As renovations proceed, we will keep you updated about progress via website updates or email.

In addition to being a time of rejuvenation, this is also a time to give thanks for our generous donors and supporters, many of whom joined us in September for our 25th Anniversary Gala celebration. The gala was a major success all around. Before it even began, we had raised \$1 million from six donors to start a Matching Gift Initiative to raise funds for the 25th Anniversary Renovation Campaign. The gala helped raise additional funds for the campaign, and was a great celebration and reunion among long-time supporters, friends, religious congregations and clergy.

My wife and I personally had a wonderful time connecting with our RHC constituency and meeting many others for the first time. The generosity before the gala and all who came from near and far really drove home the point of how much Regina Health Center means to so many. You could really feel the love for this ministry. Knowing how supportive, helpful and generous our friends and supporters are makes it that much easier for all of us to carry out our mission of providing compassionate, exceptional care to those who need it most.

And soon, we'll be providing that care in a rejuvenated home that's even more beautiful and comfortable than ever before.

RHC Receives 9th Consecutive Assisted Living Deficiency-Free Survey



Receiving one deficiency-free survey is difficult to achieve. Receiving nine in a row is truly remarkable. Regina Health Center's Assisted Living facility recently received a deficiency-free survey from the Ohio Department of Health (ODH), which marked the ninth year in a row the ministry has received this perfect rating.

"Nine years in a row is an extraordinary achievement," said Mark Yantek, executive director, Regina Health Center. "There are many, many standards that are closely scrutinized during unannounced inspections. That's why it's such an impressive feat to be deficiency free so many years in a row."

On the skilled nursing side, Regina Health Center also received an ODH deficiency-free survey earlier this year—meeting hundreds of federal and state health and safety standards to achieve a perfect survey. The survey process focuses on how the needs of residents are met, encompassing not only their medical and nursing needs, but also their social, psychological, spiritual, nutritional and physical needs. Only 10 percent of all facilities nationally and in Ohio receive a deficiency-free survey.

"With progressively more rigorous requirements, achieving a deficiency-free rating has become more difficult than ever, which shows how hard we work to ensure the health and well-being of our residents are being met. Survey results help provide insight into making an informed decision when choosing a skilled nursing facility," said Yantek. ♦

A Qualified IRA Charitable Distribution is a Great Way to Make a Matching Gift for the 25th Anniversary Renovation Campaign

For those 70½ or older who are required to take a required minimum distribution (RMD) from your IRA or some other tax-deferred retirement accounts, consider using those funds to make a qualified charitable distribution. The qualified charitable distribution involves a direct transfer from your IRA that is payable to the charity. The direct-transfer charitable distribution still counts toward your RMD. You can transfer up to \$100,000 per year per plan owner assuming you file a joint tax return. The amount transferred to charity will not be counted toward your taxable income, as would be the case with a regular, non-charitable distribution. The rules for a qualified charitable distribution are as follows:

1. You must be 70½ or older before requesting the charitable distribution.
2. You can transfer up to \$100,000 per year from your own plan.
3. Funds must be transferred by December 31 to count toward RMD for the year.
4. Funds must be transferred directly to the charity and made payable to the charity.
5. Eligible plans include Traditional and Roth IRAs.

A qualified charitable distribution is easy to process. Just call your plan administrator and they will send you the appropriate forms.

By using a qualified charitable distribution to make a gift toward Regina Health Center's 25th Anniversary Renovation Campaign, your gift will be matched by the Matching Gift Initiative, as long as the fund has not been depleted. In any case, a qualified charitable distribution makes a lot of sense, and we see many gifts of this type throughout the year.

RESIDENT SPOTLIGHT

Sister Rosemarie Robinson, OP, Set the Stage for Regina Health Center



Sister Rosemarie Robinson (formerly Margery Ann Robinson), a member of the Dominican Sisters of Peace, has had a rich and rewarding life—and was one of many who helped lay the foundation for Regina Health Center (RHC) more than a quarter

century ago. She knew at an early age that she wanted to enter religious life. She was schooled by the Dominican priests and sisters at St. Dominic Parish in Youngstown, Ohio. And, she wanted to follow in her sister's footsteps, Sister Bernadine Robinson. She became a postulant her senior year of high school. On April 13, 1947, she received her habit and religious name, Sister Rosemarie.

Sr. Rosemarie was set to attend St. John College for full-time study when an elder sister who taught at St. Bernard school in Akron became ill. Sr. Rosemarie was asked to take her place for one semester, which became seven years. She later attended St. John College and earned bachelor's and master's degrees in education.

Sr. Rosemarie went on to teach for many years and became the principal of St. Augustine School in Barberton. In 1969, she was elected to the Dominican Sisters of Peace General Council and in 1973 she became president of the congregation, serving in that position for eight years. Bishop Anthony Pilla appointed her in 1983 to serve as delegate for the religious of the Cleveland Diocese, where she served until the fall of 1991.

During that time, it became increasingly evident to her that a crisis was looming around the health care needs of the aging religious. Sr. Rosemarie said that she and Sr.

Mildred Baker, IHM, visited with just about every religious congregation in Northeast Ohio to determine the needs of their members. She discovered that it was becoming very difficult for congregations to continue to care

for their elder members. Younger members were in full-time ministry and additional staff was needed to care for infirmed members.

Following her initial assessment of need of whether existing infirmaries could be used, she reached out to the Ohio Department of Health and other government agencies to see if there was a way to care for older members without being a licensed nursing home. Alternative options were discussed with the Conference of Religious Leadership (CORL) of the diocese. They discussed a collaborative remedy where communities could be in one location and could have the companionship of other members as well as the spiritual nourishment so vitally important to them.

Sr. Rosemarie knew that the congregation of the Sisters of Charity of St. Augustine was considering repurposing a portion of its motherhouse at Mt. Augustine in Richfield, Ohio, and that they had a health care background in the diocese. She reached out to the congregation and planning ensued. Twenty-two congregations said “yes” to the resulting establishment of RHC. Twenty-five years later, Sr. Rosemarie Robinson has gone full circle and is now a resident at RHC.

Sr. Bernadine said of her sister, “Regina Health Center came together because of the willingness of the Sisters of Charity of St. Augustine and the hard work of Sr. Rosemarie to solve a serious problem for our religious friends.”

Sr. Rosemarie added, “I am thankful to be at Regina Health Center.” ♦

You Can Make a Gift to Regina Health Center and Receive Income for Life

Charitable Gift Annuities (CGA) continue to be a popular gift for many. A Regina Health Center Charitable Gift Annuity is a simple agreement between you and Regina Health Center (RHC). In exchange for your gift, RHC promises to pay you a fixed sum each year for life. After your lifetime, the remainder will go toward RHC's mission of care and compassion. A Regina Health Center CGA allows you to make a gift that will pay you income for life at very attractive fixed rates of return. Current bank certificate of deposit rates are paying up to 3% if you are lucky, but if you are 75 years old, you can establish a Regina Health Center CGA with an income rate of 6.2%, and because your income payments are partially tax-free, that is an equivalent rate of 9.5% (based on a marginal income tax bracket of 31.8%). The minimum age to establish an RHC annuity is 60. The illustration below shows how you will benefit from a CGA.

Age 75:	Certificate of Deposit	Charitable Gift Annuity
Amount	\$10,000	\$10,000
Payout	3.0%	6.2% *
Annual payments	\$300	\$620
Charitable Tax Deduction	\$0	\$4,575**

* Gift annuities are open to those 60 years or older. (Rate for a 60 year old is 4.7%). The older you are, the higher the payout rate.

**Applies to individuals who itemize. Due to the 2018 higher standard deduction, check with your tax advisor about the deductibility of your gift.

RHC Hospital Readmission Rate Well Below State Average

Hospital readmissions for patients discharged to skilled nursing facilities, while often unavoidable, can be costly. In Ohio, 16.7 percent of skilled nursing Medicare fee-for-service patients discharged from a hospital were readmitted within 30 days from April 2017 through March 2018.

The rate at Regina Health Center during the same period was 55 percent less than the Ohio average, with only 9.2 percent of patients being readmitted. Hospital readmissions are identified through Medicare claims data.

“Having such significantly lower hospital readmission rates than the Ohio average speaks to the quality of nursing care and overall care our residents receive,” said Executive Director Mark Yantek. “There are several benefits to reducing hospital readmission, first and foremost being resident quality of life. Older adults are at increased risk for detrimental effects associated with hospitalization.”

There’s also the risk of reduced Medicare value-based payments from the Centers for Medicare and Medicaid Services (CMS). The Skilled Nursing Facility Value-Based Purchasing Program focuses on better outcomes and rewards skilled nursing facilities with incentive payments for the quality of care they give to people with Medicare, in particular reducing hospital readmissions.

Resident Satisfaction Among Tops in Ohio

RHC received among the highest marks in Ohio in the most recent biennial resident satisfaction surveys for nursing and assisted living facilities from the Ohio Department of Aging (ODA). RHC scored in the top 1 percent of all Ohio assisted living facilities in the ODA resident satisfaction survey. With a score of 96.26 out of 100, Regina Health Center ranked ninth statewide and number two in Northeast Ohio.

On the skilled nursing side, RHC achieved similar high scores in the counterpart survey for nursing homes. RHC was in the top 2 percent in the ODA resident satisfaction survey. With a score of 90.30 out of 100, RHC ranked 23rd statewide and number three in Northeast Ohio for resident satisfaction.
